BAMBINI S.p.A. stands as a primary objective the pursuit of customer satisfaction and the fulfillment of the requirements expressed and implied in the service offered;


To achieve this purpose the Organization, following the principles of UNI EN ISO 9001:2015, UNI EN ISO 14001:2015 and UNI EN ISO 45001:2018, has established the following policy for quality, the environment and the health and safety at work:

- analyze and define the operational context by promoting the use of the process approach and risk-based-thinking;
- identify stakeholders by understanding their needs and expectations by monitoring and periodically reviewing relevant information;
- constantly monitor customer expectations with regard to service, naval transport, the Organization as a whole and in relation to market requirements;
- search for the best quality standards for vessels, keeping them constantly updated from a technological and regulatory point of view;
- always work in safety conditions for its own and transported personnel;
- ensure full availability of its vessels, in order to limit as much as possible service breaks by planning, whenever possible, corrective actions;
- treat the constant updating of training of both crews under the professional profile of basic skills;
- maintain high level of involvement of staff in relation to objectives and operating standards;
- maintain an effective service planning and rationally use the available resources in order to achieve management economies;
- ensure compliance with the laws in force in terms of professionalism, safety and environmental protection;
- constantly improving the performance of the SQAS, according to targets set by the Board of Directors. For this purpose the company has identified indicators, objectives and goals for its performance in these areas, which are monitored and reviewed to ensure the continuous improvement of the systems, the prevention of pollution and accidents and occupational diseases
- at operational level the the company has prepared and implemented the commitments formalized in "Company Policy" contained in the Safety Management System Manual drawn up in accordance with the provisions of IMO Resolution a. 741 (18), as amended "**International Code for safety of ships and for pollution prevention**"
